1. Current IJF contest rules and Judo Canada modifications will be enforced.
2. CWG Trials will be round robin for 5 competitors or less. In the case of divisions with 6 or more, true double knockout will be used. 1st and 2nd place contestants from CWG Trial #1 will be seeded in opposite brackets. All other contestants will be distributed randomly.
3. All other divisions will be round robin or true double knockout.
